



**8U TRAVEL B - FACTS SHEET**

<b>TUITION</b>	<p>Team Tuition: \$695 (Minimum roster size: 9-10 players)</p> <p>A \$347.50 non-refundable deposit is due at signing with the balance of \$347.50 due in 30 days. Tuition includes practices, games &amp; tournaments, administrative expenses and overhead. Refunds are defined in the player agreement and only issued for catastrophic circumstances as determined by the Ogden Jr Mustangs. The program may, at its discretion, prorate the tuition to determine the refundable amount, if any. Player Releases, from the OJM program, are not eligible for refunds. The cost of soft goods is not refundable.</p>
<b>ICE</b>	<p>Approx. 45hours practice ice (approx. 2 per week), approximately 8-10 cross-ice Jamborees per season. Practices will be at the Weber Ice Sheet, 4390 South Harrison Blvd., Ogden, Utah.</p>
<b>TRAVEL</b>	<p>Travel B teams may travel up to three out of state tournaments. Travel includes league events, tournaments &amp; weekend series events. Player and family travel is not included in tuition. Players are expected to travel to all team tournaments. Tournaments are subject to change. Plan overnight travel to Teton Valley, WY; Rock Springs, WY and potentially one more out of state tournament.</p>
<b>SOFT GOODS</b>	<p>Soft goods (uniforms &amp; team gear) are not included in tuition. Players are required to buy team jerseys, pant covers, and socks. Other soft goods may be requested by the head coach. Samples for sizing may be available during tryouts. Orders must be placed by a parent. Costs can range from \$0 for returning players to \$200+ for a player new to the Jr Mustangs. Soft goods will be invoiced separately from the Tuition fees. Players may use their jr Mustangs game jerseys and socks from the 2023-24 season.</p>
<b>COMPETITION</b>	<p>Some Travel B teams may compete in the Rocky Mountain Hockey Federation as their primary league and may participate in the local travel league (UTHL) at the discretion of the Head Coach. Most Travel B teams will compete against other Utah Travel B teams. The head coach will establish the tournament and game schedule in compliance with USA Hockey and Utah Amateur Hockey Association policies.</p>
<b>EXPECTATIONS</b>	<p>Players are expected at all events. There is no discount for missing a tournament, game series or team event. Players are expected to respect the game, teammates, coaches, officials, opposing players, and facilities. Parents and guardians are expected to act with utmost character and to abide by the USA Hockey Codes of Conduct. Parents are responsible for the conduct of their player(s) and their guests. Parents must abide by the 24-hour rule when communicating with coaches. Parents are expected to respect one another, let the coaches coach, make timely payments toward their player’s account, be supportive of the program, the players, opponents, volunteers, and the game officials. The team’s communications tools are for team business only and not to be used for other purposes.</p>
<b>ADDITIONAL COSTS</b>	<p>Any costs associated with additional tournaments, showcases, games, etc. that are not in the team’s budget or included in the player tuition (for example, choosing to extend the season with an additional tournament or series of games) will be split among parents who voluntarily choose to participate in the additional events.</p>
